Internet Access in Nevada County

is provided by a small number of national, regional and local providers. There are a variety of technologies available for Internet services in our rural area each with its plusses and minuses. Internet access speeds include both download and upload components.

All current providers offer asymmetrical speeds, with the upload speed (from you to the Internet) being much slower than the download advertised speed (from the Internet to you). Only a 100% fiber optic network – Fiber to the Home (FTTH) – would be capable of offering symmetrical speeds.

Types of Service Available and Internet Service Providers:

DSL (Digital Subscriber Service)

DSL is Internet access provided over the copper telephone network. AT&T, the incumbent local exchange carrier (telephone company), is the primary provider of DSL service. Other local and regional Internet Service Providers (ISPs) can also offer DSL service, although AT&T requires that customers maintain landline telephone service with AT&T.

AT&T is upgrading much of its local networks to U-Verse (a different version of DSL), which enables somewhat faster Internet access, but does not allow independent Internet Service Providers to ever provide you with DSL service again.

Available DSL speeds are dependent on distance from the Central Office or Remote Terminal (those big green boxes alongside the road). The further away one's location, the slower the speed available, hence many of the more outlying areas do not have access to DSL although they do have telephone service.

DSL Providers typically also provide dial-up service.

Cable

Locally, Comcast offers the fastest Internet access speeds hands down over a coaxial cable network, that may use fiber optic cable for it backbone. Suddenlink offers speeds more akin to DSL speeds. Cable bandwidth in each neighborhood is shared by all the users, which accounts for slower speeds during high-traffic times (early evenings, for instance).

Fixed Wireless

Like mobile phone service, fixed wireless service provides a wireless connection to the Internet from towers and poles on local hilltops. A dish or antenna is placed on the residence to connect to the tower, then a cable brings the service to a router inside.

Next to wireline service (such as cable or DSL) it can be the most robust and reliable broadband service in remote areas where DSL or cable is not available. Because of the geographic diversity of Nevada County and because fixed wireless service requires line-of-sight between your dish and the tower, coverage areas are spotty.

Cellular

Mobile phone providers sell USB modems that connect directly to computers for Internet access. Like mobile phone data plans, Internet data use is not unlimited. The service is dependent on cellular coverage in the area, which both AT&T and Verizon claim they will be improving over time. When this service is the only one available, it's much better than dial-up.
